> Introduction

The MN Asset Management and Tracking Tool is a software application designed to empower IT teams in effectively tracking, organizing, and optimizing both physical and digital assets within the organization, thereby enhancing control and achieving cost savings.

In V1.0 Beta1, we introduce an upgraded user interface and additional features to further streamline asset management. Additionally, this version includes bug fixes from the previous release, significantly improving the overall functionality of the application.

New Features

- 1. License Category Introduces:
 - a. Brings in handy Create, Update, and Delete (CUD) features.
 - b. Facilitates smooth asset assignment and allotment.
 - c. Elevates tracking and maintenance capabilities.
- 2. Introducing the Reports Category:
 - a. Now you can effortlessly generate reports.
 - b. Easily access your historical reports for reference.
 - c. Dive into performance charts to better understand your data.
- 3. New User Profiles Section:
 - a. Manage your personal information conveniently.
 - b. Change your password with ease to bolster security.
 - c. Access a Help Guide whenever you need assistance.

Bug Fixes

- 1. The "Delete" functionality on the asset page is non-functional.
- 2. Incorporated the "Select 2" option to implement a search feature when creating a model.
- 3. Modified the "Update" functionality to accommodate backend query alterations.
- 4. Eliminated validation requirements for specific input fields within the asset and license sections.
- 5. Introduced a user profile page.
- Addressed typographical errors in the asset and license pages.
- 7. Adjusted font sizes in the header and footer sections.
- 8. Removed the side navigation icon within the assets section.
- 9. Rectified the assign functionality, which was not operational, through logic adjustments.
